Dear Kansan,

In America right now, we're facing a lot of problems, and Congress has a lot of work to do to get our country back on track. We all want our grandchildren to live in a country that still stands for freedom, and I serve in Congress to work towards building that future. Freedom tomorrow means upholding the Constitutional rights of all Americans today. That's the lens through which I view my job in Congress and the measuring stick I use for every piece of legislation I consider. This annual report serves as an overview of my work, which I've outlined in my four-part Commitment to the Big First.

Congress needs to create an economy that's strong. According to the Congressional Budget Report, America is \$33 trillion in debt, and the federal government is deficit spending roughly \$1 trillion every year. Our energy independence has eroded, small businesses are laboring under burdensome regulations and taxes, and rampant inflation is a tax on everyone.

Congress needs to create a nation that's safe and a border that's secure. Violent crime is on the rise, drug addiction is spiking, and many parts of our country are in chaos. Meanwhile, we're still hearing calls from the far left to "defund the police," and Biden Administration policies are failing to address the open southern border, where fentanyl, criminals, and people caught up in human trafficking rings flood into our country.

Congress needs to create a future that's built on freedom. As I travel the district and meet with Kansans, I hear concerns about big government, sweeping executive orders, and infringement on basic rights like the Second Amendment and the right to life.

Congress needs to create a government that's accountable. Congress has the responsibility to conduct both rigorous oversight of the executive branch and investigations into possible corruption and criminal activity within the federal government.

Through the legislation I support, I have worked to unleash American energy, cut taxes and red tape, secure the border, and investigate recent IRS whistleblower allegations surrounding President Biden and Hunter Biden. I will always stand for freedom in the face of government overreach because whether you're a parent, a child – born or unborn, a student, a farmer, or a small business owner, you don't need the federal government trying to control your life.

Serving as your representative in Congress continues to be the honor of a lifetime. There's a lot of work left to do, but with prayer and hard work, I believe our brightest days are yet to come.

HONORING MY COMMITMENT TO THE BIG FIRST: Legislative Accomplishments in 2023

AN ECONOMY THAT'S STRONG

End Washington's Spending Addiction

- Balance the budget, grow the economy, curb inflation, decrease federal spending
- ✓ The House passed the Limit, Save, Grow Act to reduce government spending, reclaim unspent COVID-relief money, and promote pro-growth economic policies.

Cut Red-Tape and Burdensome Regulations for Agricultural Producers, Business Owners, and All Americans

- Protect stepped-up basis, oppose restrictive definitions to waters of the U.S., and delist the Lesser Prairie-Chicken
- ✓ The House and Senate passed Rep. Mann's companion resolution to prohibit the listing of the Lesser Prairie-Chicken as endangered or threatened. The House and Senate passed a joint resolution to prohibit President Biden's Waters of the U.S. rule from having the force of law. Rep. Mann sponsors a resolution recognizing the importance of stepped-up basis in preserving family-owned farms and businesses.

Support Kansas and American Agriculture & Business

- Train the next generation of highly skilled workers to solve the workforce shortage
- ✓ The House passed the Chance to Compete Act to streamline requirements of the federal hiring process.

A NATION THAT'S SAFE

Defend America's National Security and Secure the Border

- Support our troops and invest in an efficient, effective military
- ✓ The House passed the National Defense Authorization Act for Fiscal Year 2024 and the Department of Defense Appropriations Act for Fiscal Year 2024.
- Secure the southern border and stop illegal immigration
- ✓ The House passed the Secure the Border Act to finish construction of the wall at the southern border and the Schools Not Shelters Act to prohibit the use of public schools for housing illegal immigrants.
- Stop the fentanyl crisis and criminalize all forms of illicit fentanyl
- ✓ The House passed the Stop Chinese Fentanyl Act to impose sanctions on Chinese producers of synthetic opioids and hold Chinese officials accountable for the spread of illicit fentanyl, and the HALT Fentanyl Act to make the temporary classwide scheduling order for fentanyl-related substances permanent.

Support Law Enforcement

- Oppose all efforts to defund the police
- ✓ The House passed a resolution expressing support for local law enforcement officers and condemning efforts to defund or dismantle local law enforcement agencies.
- Support the hiring and retention of state and local law enforcement officers
- \checkmark The House passed a resolution commemorating National Police Week and memorializing law enforcement officers killed in the line of duty.

Remain A Global Power

- Reauthorize strong agricultural trade legislation, negotiate new international trade agreements
- ✓ Rep. Mann sponsors the Agriculture Export Promotion Act adding resources to the Market Access Program and the Foreign Market Development cooperator program for trade promotion.
- Support global food security legislation, promote U.S. goods, and stop wars before they start
- Rep. Mann sponsors the American Farmers Feed the World Act restoring the Food for Peace program to its original intent of agricultural commodity transfer.

A FUTURE THAT'S BUILT ON FREEDOM

Preserve America's Constitutional Freedoms

- Protect the lives of unborn children and their mothers
- The House passed the Born-Alive Abortion Survivors Protection Act to penalize health care practitioners who fail to provide care for an infant that is born alive from an attempted abortion. Rep. Mann also sponsors legislation that would modify the Biden Administration's rulemaking to prohibit funds for abortions and abortion referrals.
- Educate students in American history and civic engagement
- The House passed the Parents Bill of Rights to ensure that the rights of parents are honored and protected in America's public schools.
- Support the Second Amendment as a load-bearing wall to the U.S. Constitution
- The House passed a resolution to stop the U.S. Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF)'s pistol brace rule, which would criminalize firearm ownership for millions of Americans who rely on stabilizing braces and attachments. Rep. Mann also sponsors the RIFLE Act, which would create an appeals process at the ATF for Federal Firearm Licensees whose licenses to sell firearms were wrongfully revoked, restoring trust between local gun stores and the ATF.

Achieve Longer, Healthier Lives for Americans

- Improve access to rural health care, including access to telehealth services
- Rep. Mann sponsors the States Handling Access to Reciprocity for Employment (SHARE) Act, which would improve the current licensing process for health care providers and increase the number of licensed providers able to serve communities across state lines.

Support Those who Fought to Defend our Freedoms

- Improve accountability and transparency at the Department of Veterans Affairs
- √ The House passed the Military Construction, Veterans Affairs, and Related Agencies Appropriations Act for Fiscal Year 2024.
- Support America's military, work to reinvigorate civilian life after military service
- The House passed the Veteran Entrepreneurship Training Act, which would codify the Boots to Business program, a training course administered by the Small Business Administration through which veterans and their families learn the fundamentals of business management.

A GOVERNMENT THAT'S ACCOUNTABLE

Rein in the White House's Out-of-Control Policies

- Require the President to notify the American public and Congress its intent to issue any executive order pertaining to agriculture, energy, natural resources, the right to life guaranteed by the Fourteenth Amendment, the Second Amendment, and immigration into the United States.
- ✓ The House passed the Reduce Exacerbated Inflation Negatively Impacting the Nation (REIN) Act, which would require the President to provide an inflation impact estimate with respect to executive orders. Rep. Mann also sponsors the More Accountability is Necessary Now (MANN) Acts, six pieces of legislation which would require the President to report to Congress on executive orders.

Hold Washington Accountable

- End the administration's anti-fossil fuel policies and empower domestic producers to restore American energy independence
- ✓ The House passed the Lower Energy Costs Act, which would increase the production and export of American energy and reduce the regulatory burdens that make it harder to build American infrastructure and grow our economy.

Restore the People's Voice

- Conduct at least one in-person town hall in every county in the district each year
- ✓ Rep. Mann hosted 60 town halls this year one in each county in the Big First.



FARM BILL REAUTHORIZATION PUSH: House Agriculture Committee

I grew up on my family's farm and preconditioning feedlot, and I am humbled to represent Big First farmers, ranchers, feedlot managers, nutritionists, ethanol producers, ag lenders, agribusiness owners and others on the House Agriculture Committee. I am committed to bringing their voices to the table as we craft responsible and thoughtful farm and food policy. This year, the Committee held 25 business meetings and hearings to discuss opportunities for the Farm Bill.

The Big First has more than 60,000 farms and ranches and is the leading congressional district for wheat, sorghum, and beef production. In Kansas, the agricultural sector employs more than 245,000 people who contribute to more than 40% of Kansas' total economy. I recognize the importance of extending or reauthorizing a Farm Bill, and I have my sleeves rolled up, working on behalf of those who feed, fuel, and clothe the world.

In 2023, I:

- Chaired the Subcommittee on Livestock, Dairy, and Poultry, representing producers in the Big First who sell \$10 billion in livestock, dairy, poultry, and products like beef, milk, and eggs every year more than any other congressional district.
- Introduced 21 pieces of agriculturally related legislation, including the Committee-passed Promoting Precision Agriculture Act, which would involve industry in writing precision agriculture standards; the AG RESEARCH Act, which would secure robust funding support for deferred maintenance at land-grant universities; and the American Farmers Feed the World Act, which would emphasize the importance of U.S.-grown commodities in international food assistance programs.
- Worked to overturn the U.S. Department of Commerce's decision to apply astronomical tariffs on Moroccan fertilizers, in an oversight letter with more than 35 of my colleagues.



Caucuses

I serve on several informal groups in Congress known as caucuses, which members organize around shared interests and priorities. My caucuses include:

Congressional FFA Caucus

As a past Quinter FFA member, I have experienced the positive impact that agricultural education can have on young people, and the importance of investing in the next generation. The National FFA Organization, state FFA associations, and local FFA chapters equip students with the tools, resources, and experiences they need to tackle agriculture's most pressing challenges head-on.

I am proud to partner with the National FFA Organization as the co-founder and co-chair of the bipartisan Congressional FFA Caucus. When I established the Caucus in 2021, the purpose was simple: bring FFA members to the table, advocate for career and technical education, and strengthen the relationship between Congress and agricultural education.

I am proud of the work the Caucus has done this year, including:

- Introducing a resolution recognizing February 18-25, 2023, as National FFA Week;
- Introducing the Family Farm and Small Business Exemption Act, which protects farming and ranching families' student access to financial aid; and
- Holding the U.S. Department of Agriculture accountable to filling the agricultural youth organization coordinator role.

Crop Insurance Caucus

Crop insurance is one of the most important programs within the Farm Bill, and I am proud to co-chair the bipartisan Crop Insurance Caucus. Crop insurance is one of our nation's best public/private programs, and it's a market-based approach to risk management with a proven track record against volatile weather and global markets. It's good for producers, and it's good for Americans who rely on a stable supply of agricultural products for food, fuel, and fiber.

Congressional Hunger Caucus

Kansas has a powerful legacy of fighting hunger, and I am proud to carry on that legacy as the co-chair of the bipartisan Congressional Hunger Caucus. This Caucus is a forum for Members of Congress to discuss, advance, engage, and work across the aisle on issues relating to hunger and food security. International food aid, in particular, helps us stop wars before they start, strengthen markets for American producers to sell their products, and save people from starvation. America is the leader of the free world, which comes with certain responsibilities; addressing global hunger is the morally right, strategically wise, and fiscally responsible thing to do.

2023 Kansas Food and Agriculture Farm Bill Listening Session

On May 2, I hosted U.S. House Agriculture Committee Chairman Glenn 'GT' Thompson in a wheat field near Gypsum, Kansas for a Farm Bill listening session with farmers, ranchers, agricultural producers, and leaders in Kansas agriculture.

More than 150 people joined us for the conversation because we all care about American agriculture, we care about getting agricultural policy right, and we want to see American farmers, ranchers, and producers thrive. We had people with many different perspectives in attendance – people who prioritize Title 1, and people who prioritize title 12; people who care about row crops, and people who care about livestock; representatives from commodity groups and trade associations and consumer organizations. Our session was a rich, multi-faceted picture of American agriculture.

As I said at the Listening Session, we came together because Chairman Thompson and I know that the most important thing we can do is listen. I feel grateful every day to represent the Big First District, where people take the time to show up and advocate for policies that meet the needs of consumers, agricultural producers, rural communities, and the world.

The Farm Bill Impact Series

In 2022, I began delivering a series of speeches on the Floor of the House of Representatives about the Farm Bill, highlighting some of the programs and titles that I believe Congress must understand and support. The series is now up to 24 speeches in total. Below is an overview of the Farm Bill Impact Series speeches from this year, along with an excerpt from each one.

- **#17. Stepped-Up Basis, Farm Killer Tax:** "If stepped-up basis is eliminated and producers get saddled with unjust capital gains taxes, the Farm Bill won't ever be effective."
- #18. Food and Ag Listening Session: "Whether it's trudging through knee-high snow in the dead of winter, working the fields in heat of summer, or hauling water during a drought, American producers don't take days off. Agriculture inspires us to look back at our shared heritage, engage in the present, and plan for the future. That's what our Food and Ag Listening Session was all about planning for the future."
- **#19. Lesser Prairie-Chicken:** "It's time for my colleagues in the House to decide whether they want to stand for big government overregulation that puts producers out of business or stand up for producers' rights to private property and self-determination."
- **#20. National Bio and Agro-Defense Facility:** "This year's farm bill is an opportunity to lead in the areas of innovation and research. We must get animal health right, for our food security, economic security, and national security. I am proud to have this facility in my district and right down the street from K-State's School of Veterinary Medicine and the Biosecurity Research Institute creating a scientific hub that will lead the world in agricultural research and health."
- **#21. Wheat Harvest Report:** "This year's wheat harvest in Kansas is a perfect example of why crop insurance is so important, and why it's my top priority for the Farm Bill."
- **#22. Agricultural Research:** "Investing in agricultural research isn't just about new laboratories and equipment. It's about a vision for the world where America is the undisputed leader in food science technology."
- **#23. Reauthorization:** "American producers are working tirelessly to feed, fuel, and clothe the world, and they deserve the strongest possible Farm Bill."
- **#24.** A Five-Year Farm Bill: "We need a five-year Farm Bill. It's long enough to provide certainty to producers, and short enough for Congress to respond to market changes and strengthen the farm safety net accordingly."

House Transportation & Infrastructure Committee

America cannot prosper without a safe and efficient transportation network. I am proud to serve on the House Transportation and Infrastructure Committee, where I am working to improve our nation's infrastructure, strengthen transportation programs, harness innovation to safely move goods and people throughout the country, and help alleviate our country's ongoing energy and supply chain issues. The Committee is also invested in oversight of the Biden Administration's burdensome regulations. This year, the Committee successfully passed reauthorization legislation for the Federal Aviation Administration (FAA), the Pipeline and Hazardous Materials Safety Administration (PHMSA), and the United States Coast Guard.

The Big First has more than 83,000 miles of road, 4,000 miles of railroad track, and more than 100 airports. I am committed to strengthening and improving this vital transportation and infrastructure network, which supports our state's economy and impacts the lives of all Kansans on a daily basis.

In 2023, I:

- Cosponsored more than 30 pieces of transportation and infrastructure legislation, including the E-BRIDGE Act, the Short Line Railroad Relief Act, the Aviation Workforce Development Act, and a Congressional Review Act on the Biden Administration's Waters of the United States ruling.
- **Sent ten transportation and infrastructure oversight letters,** including one to the U.S. Department of Transportation regarding SkyWest's decision to continue service at several airports in the Big First.
- Submitted several Kansas priorities that were included in the 2023 FAA Reauthorization and PHMSA Reauthorization bills.



House Small Business Committee

Small businesses help drive the American economy and define the American dream. They add brick and mortar to the values that make our country unique, like freedom, self-determination, and the pursuit of happiness. I learned about the responsibility, drive, and decision-making required to operate a small business from watching my parents operate our preconditioning feedlot and family farm. The Big First is home to nearly 20,000 small businesses, and roughly 65% of employees in the Big First are employed by small businesses. I am honored to represent the Big First on the House Small Business Committee, and I will continue to defend and support small businesses, their owners, their employees, and the American values that small businesses embody.

On the House Small Business Committee, I am focused on conducting rigorous oversight of burdensome regulations forced on small businesses, advocating for pro-growth tax policies that create a better environment for small business owners to create jobs and improve their communities, and highlighting success stories of our small businesses in the Big First.

In 2023, I:

- Co-led 8 letters to hold the Biden Administration accountable for harmful rules and regulations imposed on small businesses, including one pushing back on a U.S. Environmental Protection Agency rule forcing small businesses to comply with new emissions requirements for gasoline distribution and bulk gasoline terminals; another to the U.S. Department of Justice regarding the threat of the Chinese Communist Party's theft of American small business's intellectual property; and another demanding answers from U.S. Small Business Administration regarding more than \$200 billion of wasted taxpayer money on COVID-19 loan fraud.
- Cosponsored 10 pro-growth bills that would extend the 2017 tax cuts, allow small businesses to deduct certain investments and create jobs, maintain pass-through income deductions for small business owners, and more.
- Hosted Big First small businesses owners in Washington to share their experience navigating the challenges facing small businesses, and another demanding answers from the U.S. Small Business Administration regarding the Office of Inspector General's June 27, 2023, report detailing \$200 billion of wasted taxpayer money from COVID-19 loan fraud.

Standing with Israel

On October 7, 2023, Americans watched in horror as Hamas terrorists invaded Israel and began a murder and kidnapping spree. These terrorists went into peoples' homes and killed babies in their cribs. They slaughtered people in the streets who were walking to synagogue. They kidnapped hundreds and injured thousands. According to the United States Holocaust Memorial Museum, October 7, 2023, was the deadliest day for the Jewish people since the Holocaust.

In response to these horrors, I helped introduce a resolution committing America to standing in support of our ally, Israel. I cosponsored legislation condemning Hamas' actions, supporting Israel's right to self-defense, honoring the memory of the Americans who died in the attacks, rejecting all forms of antisemitism, reaffirming America's commitment to Israel's security, and reinstating the freeze on Iranian assets to prevent them from funding terrorism. I also voted in favor of legislation to strengthen Israel's defense capabilities, bolster stockpiles of munitions to fight Hamas, enhance the security presence at the U.S. Embassy in Israel, and ensure accountability and transparency in the process.

Throughout my time in Congress I have supported, and will continue to support, Israel.

I am praying for an end to the conflict in Israel, for all hostages to be returned home safely, and for a restoration of peace. America must continue to support Israel, condemn all attacks on Israel's sovereignty, and hold the Biden Administration accountable for its continued deals with those who support Hamas and other terrorist groups.
