Dear Secretary Blinken and Acting Director Young:

In the month since the last U.S. military forces withdrew from Afghanistan, we have remained in contact with many Americans and allies still desperately seeking escape from the brutal Taliban regime. In many of these cases, our congressional offices have been the only official points of contact with the American government. We are deeply concerned and dismayed by the U.S. Department of State's lack of action to ensure these individuals escape imminent danger. The United States of America has a clear duty to assist all U.S. Citizens, Legal Permanent Residents, and Afghan allies.

Many of those still trapped in Afghanistan are hoping to reach safety via neighboring countries. It is paramount that the State Department move swiftly to coordinate with these nations to ensure their cooperation in the evacuation. The situation in Afghanistan is already unsafe and may quickly become even more dangerous. There is a considerable threat of civil war as the Taliban seeks to strengthen its hold on the country. Recent reports indicate that the Taliban has begun deploying troops along the border with Tajikistan, thereby sealing off possible escape routes. Furthermore, winter is coming, and many mountain passes will close due to snow in a few short weeks, essentially sealing the ground routes from Kabul.

We request that the State Department as well as the Office of Management and Budget:

- Transmit to Congress all necessary temporary authorizations and appropriations needs to fully execute the complete evacuation of U.S. citizens, visa holders, and Afghan allies within ten days.

- Immediately deploy consulate teams to Tajikistan, Uzbekistan, and Pakistan for the vetting of Afghans transiting through those countries to onward destinations, whether here to the U.S. or another allied country.
- Find additional temporary staging countries to increase capacity to conduct visa interviews, process cases, provide medical treatments, and issue final destination travel documents for Afghan evacuees.
- Request solicitors review delegations of authority and surnaming procedures within the State Department to remove unnecessary bureaucracy and streamline processes.
- Finally, please assign and provide all necessary personnel and resources to the Afghanistan Task Force until the end of 2022.

The State Department must find solutions to ensure that these individuals can reach safety – and have their cases moved forward in safe and secure environments outside Taliban-controlled territory. We owe it to our Afghan allies.

We ask that you respond no later than October 29, 2021.


